The following chart demonstrates the equity growth over time, highlighting the strategy's performance during the backtesting period.




Comprehensive Trade Analysis

This EA runs on **GBPUSD** and uses **Moving Averages** with your supplied **custom indicator(s)** to generate and filter trades. It uses the same risk framework (**1.0% risk, 5.0 max lots, 0.10 fallback**) and includes protective stop logic/trade management behaviour as coded.
